**No.GP-11-MKM-102008-1882-CHH:** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in superession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to post of Technician, Class III, in the subordinate Service of the Directorate of Indian System of Medicine and Homoeopathy, namely :-

- 1 These rules may be called the Technician, Class III, in the subordinate Service of the Directorate of Indian System of Medicine and Homoeopathy Recruitment Rules, 2016
- 2 Appointment to the post of Technician, Class III, in the subordinate Service of the Directorate of Indian System of Medicine and Homoeopathy shall be made by direct selection.
- 3 To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-
  - (a) not be more than 35 years of age :  
Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
  - (b) possess:
    - (i) Bachelor's degree in Pharmacy (Ayurved) for Technician in Rasshastra and Bhaishijya Kalpana of any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared to be a deemed University under section 3 of the University Grants Commission Act,1956, or
    - (ii) a Bachelor's degree in Science (Botony) for Technician in Dravyaguna or a Bachelor's degree in Science (Chemistry) for Technician in Padharth Vignan and Maulik Siddant or B.Sc. (Microbiology) for the Technician in Rogvignan and Vikrati Vignan


obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational Institution reconized as such declared to be a deemed University under section 3 of the University Grants Commission Act, 1956; and

(c) possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules; 1967

(d) possess adequate knowledge of Gujarati or Hindi or both.

4. The provision of rule, 9 A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
5. The candidate appointed by direct selection shall to undergo such training and to pass such examination as may be prescribed by the Government.
6. The candidate appointed by direct selection will be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
