No.GP/1/MKM/102014/2606/CHH: In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of the all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Staff Nurse, Class III in the Gujarat Ayurved Services, under the Directorate of Indian System of Medicine and Homoeopathy, namely:-

1. These rules may be called the Staff Nurse, Class III in the Gujarat Ayurved Services, under the Directorate of Indian System of Medicine and Homoeopathy, Recruitment Rules, 2017.
2. Appointment to the post of Staff Nurse, Class III in the Gujarat Ayurved Services, under the Directorate of Indian System of Medicine and Homoeopathy shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, candidate shall,-
 - (a) not be more than 45 years of age;
 - (b) possess Diploma of Ayurvedic Nursing i.e. qualified Ayurved Nursing Course Certificate obtained from Gujarat Ayurvedic Nursing Faculty established by the Government of Gujarat;
 - (i) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967;
 - (ii) possess adequate knowledge of Gujarati or Hindi or both.

4. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
5. The candidate appointed by direct selection shall require to get himself registered with the Gujarat Board of Ayurvedic and Unani System of Medicine at the time of making an application for direct selection, if he is not so registered.
6. The candidate appointed by direct selection shall undergo such training and pass such examination as may be prescribed by the Government.
7. The candidate appointed by direct selection shall furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.



No.GP/50/MKM/102014/2606/CHH:- In exercise of powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Staff Nurse, Class III, in the Gujarat Ayurved Services, under the Directorate of Indian System of Medicine and Homeopathy Recruitment Rules, 2016, namely:-

1. These rules may be called the Staff Nurse, Class III, in the Gujarat Ayurved Services, under the Directorate of Indian System of Medicine and Homeopathy Recruitment (Amendment) Rules, 2017.
2. In the Staff Nurse, Class III, in the Gujarat Ayurved Services, under the Directorate of Indian system of Medicine and Homeopathy Recruitment Rules, 2016, for rule 5, the following shall be substituted, namely:-
"5. The candidate shall be required to get himself registered with the Gujarat Board of Ayurvedic and Unani System of Medicine, at the time of his application for direct selection, if he is not so registered."
