Constitution of India: No. GP-241-DR-1076-8176-Chh:- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules of Assistant Pharmacist in the Ayurved Department, namely :-

1. These rules may be called the Assistant Pharmacist in the Ayurved Department Recruitment Rules, 1977.

2. Appointment to the post of Assistant Pharmacist in the Ayurved Department shall be made by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate must :

a. be not more than 35 years of age;

b. possess a degree of -

i. B.Pharm(Ayurved), Gujarat Ayurved University or

ii. B.S.A.M. (Gujarat) or

iii. D.S.A.C. (Ayurved Pravin) Gujarat, or

iv. Ayurved Visharad (Bhavnagar)

c. have experience of manufacturing Ayurved medicines for a period of about two years gained after obtaining the qualification in sub rule (b) above.

Provided that the upper age limit may be relaxed in favour of a candidate possessing post-graduate qualification.

Provided further that the upper age limit may be relaxed in favour of a candidate who is already in the service of Govt. of Gujarat in accordance with the provisions of the Govt.

Civil Services Classification and Recruitment (General) Rules, 1967 are amended from time to time.

4. The selected candidate shall be on probation for a period of one year.

5. The selected candidate shall be required to pass an examination in Gujarati or Hindi or both in accordance with the rules made by the Government in that behalf.

6. The selected candidate shall be required to undergo such training as may be prescribed by the Government from time to time.
