**CONSTITUTION
OF INDIA.**

No.GP/18 /RRS-MKM-102009-1632-CHH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of ELECTRICIAN, CLASS III, in the subordinate service of the Directorate of Indian System of Medicine and Homoeopathy, Gujarat State, namely :-

1. These rules may be called the Electrician Class III, (Directorate of Indian System of Medicine and Homoeopathy) Recruitment Rules, 2015.
2. Appointment to the post of Electrician, Class III, in the subordinate service of the Directorate of Indian System of Medicine and Homoeopathy, Gujarat State, shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2 a candidate, shall,-

(a) not be more than 28 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(b) possess

(i) a Diploma in Electrical obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or a certificate of ITI in Electrical Trade;

(ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967; and

(iii) adequate knowledge of Gujarati or Hindi or both.

(c) have secured a competency certificate from the Roads and Buildings Department; and

(d) have about three years experience as a Wireman in Government, Government Undertaking, Board, Corporation, Limited Company established under the Companies Act, 2013, registered private organisation or public sector organisation.

4. The provision of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
5. The selected candidate shall, require to undergo such training and pass such examination as may be prescribed by the Government.
6. The selected candidate shall, require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
