
No:GP- -MKM-102009-1552-CHH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to post of Compounder (Ayurved), Class III in the subordinate service of the Directorate, Indian System of Medicine and Homoeopathy, namely :-

- 1 These rules may be called the Compounder (Ayurved), Class III Recruitment Rules 2015.
- 2 Appointment to the post of Compounder (Ayurved), Class III in the subordinate Service of the Directorate, Indian System of Medicine and Homoeopathy shall be made by direct selection.
- 3 To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-
 - (a) Not be more than 30 years of age:
Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
 - (b) Possess Bachelors degree in Pharmacy (Ayurveda) obtained from any of the Universities established or incorporated by or under the Central or a State Act In India; or any other educational institutions recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956.
- 4 The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
- 5 The selected candidate shall require to undergo such training and to pass such

examination as may be prescribed by the Government.

- 6 The selected candidate shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
